

#### MINUTES OF MEETING

Call to Order – The City of Guyton Council held a Council Meeting on May 11, 2021 at the City of Guyton Gymnasium, 505 Magnolia Street in Guyton. This meeting was called to order by Mayor Russ Deen at approximately 7:05p.m. Mayor Russ Deen, Mayor Pro Tem Michael Johnson, Sr., Council Member Joseph Lee, Council Member Hursula Pelote, and Council Member T. Marshall Reiser were present at this meeting. Other Administrative Staff Present – Interim City Manager Mike Eskew, City Attorney Brian Griffin and Interim City Clerk Jenna Tidwell were present. Guest Present – The guests sign-in sheets are filed in the office of the City Clerk.

**Invocation** – Pelote gave the invocation.

Pledge of Allegiance – The Pledge of Allegiance was led by Russ Deen.

Consideration to approve or amend the Agenda – Mayor Deen made a motion to amend the agenda by adding item "m" under New Business (to approve expense GIRMA Liability Insurance) and adding item "n" under New Business (to approve the City Clerk position to be open to applicants) Pelote made a motion to approve the amended agenda as presented. Johnson seconded the motion. **Motion passed unanimously.**

### **NEW BUSINESS**

First Reading of the FY2021/2022 Budget – Mayor Deen read the first reading of the FY2021/2022 Budget Ordinance # 2021-04.

Consideration regarding Dilmus Jackson CDBG Grant — Pelote made a motion to discontinue the current CDBG project for the possibility of not being approved due to many properties that had vacancies. Reiser seconded the motion. Motion passed unanimously.

Consideration to approve Utility Bill Repayment Plan - Johnson made a motion to approve the Utility Bill Repayment Plan. Pelote seconded the motion. Motion passed unanimously.

Consideration to approve a postcard billing system for water/sewer/trash services –Failed due to lack of motion.

Consideration to approve purchase of a Pressure Sealer, if required - Pelote made a motion to approve the purchase of the FP SFS3000C pressure sealer/paper folder for our current billing system. Reiser seconded the motion. Motion passed unanimously.

Consideration regarding vote for GMA District 12 Officers – Reiser motioned to vote for the listed President, (Jonathan McCollar, Mayor, Statesboro Rey) 1<sup>st</sup> Vice President, (Allen Brown, Mayor, Hinesville) 2<sup>nd</sup> Vice President, (Beth Goette, mayor, Thunderbolt) and to nominate Mayor Deen for 3<sup>rd</sup> Vice President. Pelote seconded the motion. **Motion passed unanimously**.

Lee seconded the motion. Motion passed unanimously.

Consideration to approve GIRMA Liability Insurance Expense – Johnson made a motion to approve GIRMA Liability Insurance expense. Pelote seconded the motion. Motion passed unanimously.

Consideration to open the City Clerk position be open to applicants — Pelote made a motion to open applications for the City Clerk of Guyton. Lee seconded the motion. Reiser was in agreement. Mayor Deen oppose. Motion passed.
